## Terms and Conditions

1. The competition starts on Monday, 23 March 2026 and ends Sunday, 10 May 2026.
2. Sign up to SPAR Rewards to be eligible to enter the competition.
3. Buy any of the participating Win a Car products from any SPAR or TOPS at SPAR store and swipe your SPAR Rewards card for automatic entries into the competition.
4. Qualifying products are depicted on in-store advertising material. A list of these qualifying products is also available at [www.spar.co.za/winacar](http://www.spar.co.za/winacar)
5. Each participating product, purchased with an accompanying swipe of a SPAR Rewards card, is a single entry into the competition. Buying multiple participating products will give you automatic multiple entries.
6. TOPS at SPAR participating products are not available to persons under the age of 18.
7. You may enter this competition as many times as you like.
8. To see how many entries you have received during the Win a Car competition, retain your till slips. The total entries received per transaction will be on the second printed till slip you receive, after your transaction has been finalised.
9. By swiping your SPAR Rewards card, you are accepting all the rules of this competition.
10. There will be seven (7) draws during the competition, whereby SPAR will draw the winners weekly by means of a random electronic draw.
